RESOLUTION No. 116, 2019

A RESOLUTION DECLARING AN INTENT TO ISSUE AND AUTHORIZING THE ISSUANCE AND PUBLICATION OF NOTICE OF A NEW CLUB LIQUOR LICENSE, USING THE HISTORICAL METHOD, IN THE CITY OF LINWOOD

WHEREAS, The City of Linwood adopted Ordinance 10, 2019, which amended the Linwood Alcoholic Beverages Ordinance and created two Club Liquor Licenses in the City of Linwood, on May 8, 2019; and

WHEREAS, it is the intent of the City of Linwood to issue one Club Liquor License, using the Historical Method, and to accept applications therefore from all interested parties in accordance with NJSA 33:1-19.1 and 19.2; and

WHEREAS, the City of Linwood intends to publish two notices in a local newspaper to advise the public of the City's intention to issue one new Club Liquor License and to accept applications therefore; and

WHEREAS, the City of Linwood intends to hold a public hearing on the issuance of the Club Liquor License, on August 14, 2019 at the regularly scheduled Linwood Council meeting, following which it is the intention of the Linwood Common Council to adopt Resolutions to award the Club License and to issue the Club License:

NOW, THEREFORE BE IT RESOLVED, by the Common Council of the City of Linwood that it hereby expresses its intent to issue one Club Liquor License, using the Historical Method, and to accept applications therefore from all interested parties;

BE IT FURTHER RESOLVED, by the Common Council of the City of Linwood that applicants must be qualified to hold an interest in a club license under the standards set forth in the Alcoholic Beverage Control Act, the Rules and Regulations promulgated thereunder, and any applicable municipal ABC Ordinances. Applicants shall submit a completed 12-page application for a club license and additional documentation to establish applicant is a "club" complying with the membership, clubhouse and other requirements of N.J.A.C.13:2-8.1 et seq.;

BE IT FURTHER RESOLVED, by the Common Council of the City of Linwood that the City Clerk be and is hereby duly authorized, empowered and directed to advertise a Notice of Intent in a newspaper circulating generally in the municipality on two separate occasions, which publications shall be not less than one week apart and the second of which shall be not less than thirty days prior to the public hearing, issuance and award of the Club License;

BE IT FURTHER RESOLVED, by the Common Council of the City of Linwood that the final date established to accept and to open all applications

shall be on August 7, 2019 and no applications shall be accepted thereafter;

BE IT FURTHER RESOLVED, by the Common Council of the City of Linwood that there shall be a public hearing on the issuance of the Club License on August 14, 2019 at the regularly scheduled Linwood Council meeting, following which it is the intention of the Linwood Common Council to adopt Resolutions to award the Club License and to issue the Club License.
