PLEASE BE ADVISED THAT ON:

Friday, October 24, 2014 through Monday, October 27, 2014

MILLING & PAVING WORK WILL BE PERFORMED ON YOUR STREET IN LINWOOD as part of the South Jersey Gas Utility Project.

WE REQUEST THAT RESIDENTS DO NOT PARK ON THE STREETS BETWEEN 7:00 am AND 5:00 PM. We typically mill on day 1 and follow with paving on day 2, weather permitting.

YOU CANNOT PARK ON THE STREET AND YOU SHOULD REMOVE CARS FROM YOUR DRIVEWAY NO LATER THAN 7:00 AM.

THEY WILL BE ABLE TO RETURN ON OR ABOUT 5:00 PM.

RESIDENTS MAY EXPERIENCE MINOR DELAYS LEAVING OR RE-ENTERING THEIR DRIVEWAYS DURING ACTUAL PAVING OPERATIONS DUE TO THE DROPOFF AT THE STREET. ENTER AND EXIT YOUR DRIVEWAYS SLOWLY TO AVOID THE DROPOFF. PLEASE NOTE THAT OUR WORK CAN BE AFFECTED BY THE WEATHER SO THE SCHEDULE MAY BE ADJUSTED ACCORDINGLY.

FOR YOUR SAFETY AND PROTECTION, PLEASE DO NOT MOVE ANY TRAFFIC DEVICES. **PLEASE LOCATE, AND TURN OFF ANY SPRINKLER SYSTEMS** IN THE WORK ZONES THAT MAY INTERFERE WITH THE PAVING.

WHEN THE ROAD IS BEING PAVED **DO NOT DRIVE ON THE HOT ASPHALT OR THE TACKED ROADWAY**. IF YOU DRIVE ON THE HOT ASPHALT, YOU WILL DAMAGE OUR WORK. <u>IF YOU DRIVE ON THE TACKED ROADWAY</u>, YOU WILL GET TACK ON YOUR CAR TIRES WHICH WILL GET ON YOUR DRIVEWAY.

IF REQUIRED, SPECIAL ACCESS NEEDS TO SPECIFIC PROPERTIES CAN BE ADDRESSED WITH THE SITE SUPERVISOR.
